

Pour Over Will

I, _____, receiving mail at _____ hereby declare this to be my Last Will and Testament, and I expressly revoke all Wills, including codicils, which I individually have made previously.

Article 1. I give the entire residue of my estate to the trustee then in office under that trust designated as _____ **FAMILY LIVING TRUST**, whose written communication address is _____. I direct that the residue of my estate shall be added to, administered, and distributed as part of that trust, according to the terms of the trust and any amendment made to it before my death. To the extent permitted by law, it is not my intent to create a separate trust by this will or to subject the trust or the property added to it by this will to the jurisdiction of the probate court.

Article 2. If the disposition in Article 1, above, is inoperative or is invalid for any reason, or if the trust referred to in Article 1, above, fails or is revoked, I incorporate herein by reference the terms of that trust, as if executed on this date, without giving effect to any amendments made subsequently, and I bequeath and devise the residue of my estate to the trustee named in the trust as trustee, to be held, administered, and distributed as provided in this instrument.

Article 3. I hereby nominate _____, whose written communication address is _____, to be the Executor of this Will. In the event she may be unable to serve or declines to serve as the Executor of this Will, I hereby nominate _____ (**my** _____), whose written communication address is _____, to so act as my attorney-in-fact, as First Alternate Executor.

The Executor shall have full power and authority to carry out the provisions of this Will, including the power to manage and operate during the probate of my estate any property and any business belonging to my estate.

The Executor shall serve without bond.
